I'm Co-Chair of Hui E! Community Aotearoa, one of four organisations that have partnered to bring you this webinar, with support from the Todd Foundation. We've proven in Aotearoa over the past few months and years what can be achieved when we unite; when we put people first; when we strive for peace and love.
